Chief Report 12/13/2024

North Division Operations:

The end of peak staffing will be December 16th, 2024. We will transition to our winter staffing model and begin our Amador period on that date.

Camp Operations:

Transitioning to winter staffing, we will have one crew staffed during the week, with the crew on-call for the weekend if needed. Crews will be working on several projects in the Division, including the Cobb School/Boggs Forest clean-up. That project intends to clear lots of accumulated dead and down debris around the school during the winter break, with some associated pile burning. School staff is very excited to return the nature trail that existed before the Valley Fire to a usable state, allowing for guided student educational opportunities.

South Lake Operations:

We had a very successful 'Candy Cane Run' in 2024. Thousands of candy canes, handshakes, and smiles were delivered to the district's residents throughout the three-day event.

The South Lake Association also successfully held the blood drive, but I will let them give a report on that event.

Chief Lau has been busy getting familiar with District operations, personnel, fleet, and facilities.

We are continuing the search for a used tractor for the CLERC grant towards purchasing a tractor and trailer to move our fuels excavator.

Work on the Hidden Valley Station build continues, with the potential for a completed set of building plans to be submitted to the County of Lake for a plan check/review in the next two months. The bid package will be sent to our attorney to prepare those documents. The plans are also being reviewed by a cost-estimating service to give a more accurate cost estimate of the building to fund the project.

Fleet staff are working on final edits to the next Ambulance order. Several items were identified to improve functionality and durability. The vehicles are on a 24-30-month delivery window.

LAKE COUNTY OPERATIONAL AREA AGREEMENT

This Agreement is made and entered into as of December 11, 2024, by and between the County of Lake ("County"), the incorporated City of Lakeport, the City of Clearlake, and all special districts and relevant agencies within Lake County that agree to participate in the Operational Area framework, as documented by the County Office of Emergency Services (OES) (hereinafter collectively referred to as the "Parties").

PURPOSE:

The purpose of this Agreement is to establish the Lake County Operational Area (OA) and define the roles and responsibilities of the Parties in emergency management, ensuring compliance with the California Standardized Emergency Management System (SEMS).

OBJECTIVE:

The objective of this Agreement is to enhance the ability of Lake County and its jurisdictions to:

- 1. Coordinate multi-jurisdictional and multi-agency emergency response.
- 2. Effectively utilize available resources across the operational area.
- 3. Ensure compliance with SEMS, enabling access to state disaster assistance.
- 4. Facilitate mutual aid within the operational area and with adjacent areas.
- 5. Support recovery operations following emergencies and disasters.

RECITALS:

WHEREAS, the potential for a major catastrophe due to earthquake, flood, or other natural or human-caused disaster necessitates the preparedness of all governmental entities within Lake County to share resources and information for the protection of public welfare; and

WHEREAS, greater efficiency in mitigation, planning, response, and recovery can be achieved by uniting the efforts of special districts, cities, and the County through pre-disaster agreements; and

WHEREAS, California Government Code §§ 8559, 8605, and 8607 defines an Operational Area as an intermediate level of the state emergency services organization, establishing SEMS for disaster response and recovery operations; and

WHEREAS, California Code of Regulations, Title 19, Division 2, Office of Emergency Services, §2409 requires local governments within a county geographic area to be organized into a single Operational Area; and

WHEREAS, Chapter 6 of the Lake County Code of Ordinances defines the purpose of preparing and executing emergency plans for the protection of persons and property within Lake County.

AGREEMENT:

- Operational Area Organization:
 The Parties agree to participate in an Operational Area Organization, which will include:
 - a) County Government: The County Office of Emergency Services (OES), under the direction of the Sheriff's Office, will act as the primary coordination point for multi-jurisdictional emergency operations, facilitating resource management, communication, and mutual aid requests.
 - b) Incorporated Cities: The City of Lakeport and the City of Clearlake will manage emergency activities within their jurisdictions but shall coordinate with the County OES for resource support and information sharing when their capabilities are exceeded or when multi-jurisdictional coordination is required.

- c) Special Districts: Special districts shall support emergency operations within their areas of responsibility (e.g., fire protection, water supply, utilities) by coordinating through the County OES. A current list of participating special districts will be maintained by the County OES.
- d) Non-Governmental and Private Sector Partners: Agencies such as hospitals, utilities, and non-profits will align their emergency plans and operations with this Agreement.

2) Responsibilities of the Parties:

- a) County of Lake: Activate the Emergency Operations Center (EOC) during significant emergencies, coordinate resource management and mutual aid requests, serve as the liaison with Cal OES, and maintain the Operational Area Emergency Plan.
- b) City of Lakeport and City of Clearlake: Maintain individual Emergency Operations Plans (EOPs or, at their discretion, annex to the Operational Area Emergency Operations Plan (OA EOP) to align with countywide emergency management efforts. Regardless of their choice, the cities shall maintain the capacity to operate their own Emergency Operations Centers (EOCs) and coordinate emergency activities with the County EOC during incidents, ensuring seamless integration of resources and operations.
- Special Districts: Provide support to emergency operations within their jurisdictions and communicate with the County EOC.
- d) All Parties: Ensure staff are trained in SEMS and NIMS principles, participate in countywide emergency drills, and conduct timely damage assessments.

3) Coordination and Communication:

- a) The County EOC shall serve as the primary coordination center during multi-jurisdictional incidents.
- b) The City of Lakeport, the City of Clearlake, and participating special districts shall establish communication links with the County EOC for situation reports, resource requests, and information sharing. The County Office of Emergency Services (OES) shall maintain a current list of participating special districts for reference.
- c) In significant emergencies, County OES will coordinate with Cal OES to request additional mutual aid resources.
- d) When the County EOC is not activated, the County OES will serve as the central coordination point for emergency management-related information sharing, planning support, and resource coordination, ensuring continuity in preparedness and response efforts.

- 4) Activation of the Emergency Operations Center (EOC):
 The Operational Area (OA) exists as an established framework for emergency coordination at all times. However, the Emergency Operations Center (EOC) or specific OA protocols may be activated as outlined in the Lake County Emergency Operations Plan (EOP). Common conditions that may trigger EOC activation include, but are not limited to:
 - a) Local emergencies impacting multiple jurisdictions within Lake County.
 - b) Mutual aid requests that exceed the resources of local jurisdictions.
- 5) Funding and Reimbursement:
 - All parties agree that, should an agency seek reimbursement for eligible emergency response and recovery activities under the California Disaster Assistance Act (CDAA) and FEMA Public Assistance (PA) programs, the primary jurisdiction responsible for the geographic area where the costs were incurred shall apply for reimbursement.
 - i) If an assisting agency incurs costs while supporting operations within the primary jurisdiction, it must provide all required forms and documentation, fully completed, to the primary jurisdiction in a timely manner. This documentation must be prepared to allow the primary jurisdiction to forward it directly to the appropriate state or federal funding source without further modification.
 - ii) Costs incurred during emergency operations will be documented and, where applicable, submitted to the County Office of Emergency Services (OES) for coordination with state and federal agencies.
- 6) Term of the Agreement:
 This Agreement shall remain in effect until amended or terminated by mutual agreement of all Parties.
- 7) Amendment and Additional Parties
 - a) Joining the Agreement:
 - i) Additional entities may join this Agreement by submitting a written request and a formal resolution or similar authorization from their governing body to the County Office of Emergency Services (OES), agreeing to the terms of this Agreement. A template resolution is provided as Exhibit A to assist entities in preparing their submission.
 - b) Approval Process:
 - i) The County OES, in consultation with the Disaster Council and current signatories, will review the request for compliance. Upon verification, the entity will be added to the Master List of Signatories as an exhibit to the Agreement without requiring formal re-approval by existing parties.

- c) Notification and Recordkeeping:
 - i) The County OES will:
 - (1) Notify all Parties of new additions or withdrawals.
 - (2) Maintain and update the Master List of Signatories (Exhibit B) as necessary.
 - (3) Distribute updates annually or as significant changes occur.
 - (4) Updates to the Master List shall be distributed to all Parties annually or as significant changes occur.
- 8) Termination:
 - i) Each Party may terminate this Agreement, with or without case, upon thirty (30) days written notice to the other Parties.

RESOLVED, by the Board of Directors of the South Lake County Fire Protection District that it finds, determines and hereby declares THAT:

- 1) The Official Canvass of the Votes Cast at the General Election held on November 5, 2024, was presented by the County Elections Official.
- 2) Pursuant to Section 15400 et seq. of the Election Code, State of California, based on the certification of the results of the November 5, 2024, General Election the Board of Directors declares the results of the following under its jurisdiction:

SOUTH LAKE COUNTY FIRE PROTECTION DISTRICT MEASURE "T"

"Shall the South Lake County Fire Protection District, without increasing the tax rate, establish an annual appropriations limit in the amount of \$1,250,000 and the amount of the special tax levy in District Ordinance No. 2018-19-01 approved by the voters in November 2018, and annually adjusted pursuant to Article XIIIB of the California State Constitution; which shall be effective for the 2024-2025 fiscal year and three years thereafter, adjusted annually for changes in the cost of living and population?"

73.23% (3,657) of the votes cast were in favor of the measure and 26.77% (1,337) of the votes cast were against the measure.

3) Two thirds of voters voting on Measure T voted in favor, and that results of Measure T is accepted and hereby deemed adopted and ratified.

FIRST AMENDMENT TO TEMPORARY LAND USE LICENSE

This First Amendment to Land Use License (the "Amendment") is entered into effective as of January 1, 2023 ("Effective Date") by and between Geysers Power Company, LLC, a Delaware limited liability company ("GPC"), and South Lake County Fire Protection District ("SLCFPD"), collectively, the "Parties."

RECITALS

- A. GPC and SLCFPC entered into that certain written Temporary Land Use License dated December 1, 2017 ("License Agreement") for the Licensed Area located on 11765 Socrates Mine Road, Middletown, near the community of Anderson Springs, Lake County, California, as more particularly defined and described in the License Agreement and depicted on Exhibit 1 attached hereto.
 - B. The parties desire to amend the License Agreement on the terms set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants, terms and conditions set forth herein, and for other good and valuable consideration, the sufficiency of which are hereby acknowledges, the parties agree as follows:

- 1. <u>Location</u>. The first sentence of Section I.A.3. shall be replaced with the following: "Attached hereto as <u>Exhibit 1</u> and incorporated herein by reference is a depiction of the location of the Licensed Area."
- 2. <u>Term.</u> Section I.B.1. shall be amended to replace "December 31, 2022" with "December 31, 2025."
- 3. <u>Insurance Requirements.</u> Section III.A.1(b) shall be amended to add to the end of the sentence: "including employer's liability coverage of \$1,000,000 per accident or disease." Section III.A.2 shall be replaced by the following: "Where allowable by law, SLCFPD waives all rights of subrogation and shall cause its insurers to waive subrogation in favor of GPC for recovery of damages. The waiver of subrogation clause (transfer of rights) shall be included on policies and evidenced on certificates of insurance. The commercial general liability and business automobile liability insurance shall be endorsed to provide that GPC is included as an "Additional Insured" on a primary and non-contributory basis. Thirty (30) days' advance notice shall be provided to GPC by SLCFPD before any cancellation or non-renewal shall take effect, and SLCFPD shall immediately forward any such notification to GPC. Annually upon each policy renewal, SLCFPD shall furnish GPC with certificates of insurance evidencing all required insurance for SLCFPD."
- 4. <u>Indemnity</u>. Section II.A.1. shall be amended to add the following to the end: "SLCFPD hereby assumes all risk of damage to or theft of the Equipment and any of its other property and all risk of damage arising from or related to the Licensed Area or directly or indirectly from any state or condition of the Licensed Area or part thereof, and SLCFPD hereby

waives all claims in respect thereof against GPC." Section II.A. shall be amended to add: "5. This Section II shall survive expiration or termination of this Agreement."

- 5. <u>Payment</u>. SLCFPD agrees to pay GPC Ten Dollars (\$10.00) for extension of the Term of the License Agreement, on the terms set forth herein.
- 6. <u>Miscellaneous.</u> The License Agreement, as amended by this Amendment ("Amended Agreement"), represents the complete expression of the Parties with respect to the matters addressed herein. All previous discussions and agreements, whether oral or written, are hereby superseded ad replace by the Amended Agreement. Each of persons signing this Amendment on behalf of the respective parties expressly warrant and represent that he or she has the full and complete authority to execute the Agreement on behalf of that party. Execution and delivery of this Amendment by exchange of facsimile or Portable Document Format ("PDF") copies bearing the signature of a party hereto shall constitute a valid and binding execution and delivery of this Amendment by such party. Such facsimile and PDF copies shall constitute enforceable original documents. Except as expressly modified herein, all of the terms, covenants, conditions, and provisions of the License Agreement shall remain unchanged and continue in full force and effect.

TEMPORARY LAND USE LICENSE ("Agreement") Between Geysers Power Company, LLC And South Lake County Fire Protection District

This Agreement, dated **December 1, 2017** ("Effective Date"), is entered into, by and between **Geysers Power Company**, **LLC**, a Delaware Limited Liability Company ("GPC"), and **South Lake County Fire Protection District** ("SLCFPD"), collectively the "Parties", for the purpose of providing SLCFPD access to property owned or controlled by GPC. The Parties agree as set forth hereafter.

RECITALS

WHEREAS, SLCFPD in cooperation with the Lake County Sheriff Department has asked GPC to allow access to a small portion of a parcel of land owned, operated, or controlled by GPC, which is located at 11756 Socrates Mine Road, Middletown near the community of Anderson Springs, Lake County, California ("License Area"); and

WHEREAS, SLCFPD shall install, program and operate a community notification siren consisting of a single telephone pole, an electric powered siren, and a battery backup system (collectively the "Equipment") at the License Area; and

WHEREAS, SLCFPD herein has agreed to accept the risk of loss or damage of its Equipment; and accept full responsibility arising from and related to the use of the License Area and its use of the Equipment. SLCFPD agrees to defend, indemnify and hold GPC harmless from any liability or damage which might result from said access or use.

NOW WHEREFORE, for the mutual promises and other good and adequate consideration described herein, the Parties agree as follows:

I. Requested Use of GPC property

A. Location

- 1. GPC shall provide SLCFPD temporary, non-exclusive, access to a portion of real property commonly referred to as Socrates Warehouse, and referred to herein as the Licensed Area. This property is also identified by Lake County Assessor's Parcel Number 013-057-201-000. In addition, GPC shall provide SLCFPD exclusive access to and possession of the Equipment described herein and to be located within the License Area.
- 2. GPC cannot guarantee a reliable power supply for the SLCFPD siren and equipment. However, GPC will make available to SLCFPD a 60 amp 120/240 volt AC electrical receptacle for SLCFPD to utilize to power the battery charger / battery system for the electrically powered community notification siren. SLCFPD should not rely on this power supply, which may be interrupted or intermittent, and SLCFPD assumes all risks arising from this unreliable

power supply. The service requirements and location were specified by SLCFPD and/or their installing contractor.

- 3. Attached to this Agreement and incorporated herein is a photograph showing the general location and boundaries of the License Area. This Agreement shall not be interpreted as giving SLCFPD any rights to use or access real property not depicted in the attached exhibit, or described above.
- 4. GPC shall grant SLCFPD access to the License Area between the hours of 6:30 a.m. and 5:00 p.m., Monday Friday (excluding holidays). Should SLCFPD require access to the License Area outside of the hours authorized in the previous sentence, SLCFPD shall call the following GPC Representative to arrange a mutually agreed upon time to access the License Area.

B. Duration of License

- 1. The initial term of this License commences on the Effective Date and ends December 31, 2022. Unless earlier terminated, at the end of the initial term of this License the Parties have the option to extend the term annually until December 31, 2027. Such extension(s) shall be in writing and executed by the Parties.
- 2. The Parties further agree that no extension of the License term period, or the right to use the License Area, shall be permitted or shall occur without the express prior written consent of GPC. At the end of each term, if the Parties do not agree to renew the License for another term, SLCFPD shall have twelve (12) months to: a) relocate the Equipment at no charge to GPC; or b) abandon the Equipment and surrender ownership of Equipment to GPC. However, if the Equipment is abandoned by SLCFPD, GPC shall not be responsible to continue to operate the Equipment and shall have no responsibility or liability for the condition or operation of the Equipment.

C. Use of the Subject Property

- 1. SLCFPD shall utilize the License Area only for the limited purpose of installing, operating, testing, and maintaining its Equipment. SLCFPD shall be solely responsible for its Equipment, and assumes all risks inherent in installing, using, operating, testing, maintaining, and replacing the Equipment. SLCFPD's access is non-exclusive and GPC shall retain the right to access the License Area.
- 2. It is understood that the activation and the testing of the Equipment is done remotely using radio frequencies. SLCFPD shall provide GPC with its testing schedule prior to any tests being performed. Should SLCFPD have an occasion to test the Equipment outside of the test schedule, SLCFPD shall provide GPC 72 hours advanced notice by contacting the following GPC Representative(s).

- 3. SLCFPD is permitted to erect and maintain temporary fencing and gates with a locking device, to enclose its Equipment. If SLCFPD does not elect to add additional fencing, SLCFPD acknowledges that it has evaluated the current fencing around the Location and determined that it is sufficient for the purpose of this License. GPC shall have no liability related to or arising from the surrounding fencing, or lack thereof.
- 4. SLCFPD agrees not to store any dangerous, toxic or hazardous materials or pollutants, on the License Area.
- 5. SLCFPD agrees to fully and completely comply with all local, state and federal laws, ordinances and regulations pertaining to its use of the License Area and the existing obligations imposed on GPC for the use the License Area.
- 6. SLCFPD acknowledges that GPC has not made any representations regarding the appropriateness of the License Area for uses intended by SLCFPD. Further, SLCFPD acknowledges that GPC has made no representations regarding the use of the License Area as being safe, effective, or appropriate for use as a community notification siren location. SLCFPD agrees that it has independently evaluated all aspects of the License Area and has determined for itself that it is safe, effective, and appropriate for the intended use of its Equipment. SLCFPD further acknowledges and agrees that GPC and its officers, agents and employees cannot be expected to control any of said risks of Equipment on the License Area. All use by SLCFPD, its agents and assigns, of the License Area is at their sole risk.
- 7. SLCFPD agrees that its operations on the License Area shall not, in any way, unreasonably impact nor damage the ongoing GPC operations. SLCFPD agrees that, if it, or its use of the License Area, does cause bodily injury or cause physical damage to GPC's operations, SLCFPD will reimburse GPC for such injury or damage.
- 8. This License shall be revocable for convenience by GPC during the term of this Agreement upon sixty (60) days written notice to SLCFPD, or in the case of a material breach of the terms set forth herein this License can be terminated upon written notice by GPC to SLCFPD.
- 9. Following the expiration, termination or abandonment of this Agreement, SLCFPD will restore the License Area, and any other area impacted by its operations under this Agreement, to the original condition, normal wear and tear excepted.

II. Indemnity

A. Indemnity

1. In consideration of the granting of this License, SLCFPD agrees that, in addition to the other indemnities provided for in this Agreement, it agrees to indemnify, defend and hold GPC and its employees, agents and authorized vendors harmless from and against any claim, demand, liability, loss, damage, cause of action, cost, expense, award, fine, judgment, lien

or attorney's fee arising from or associated with, in any way, the use of the License Area and Equipment, including, without limitations, personal injuries, wrongful death, damage to or destruction of property. This indemnity shall be broadly interpreted and applied to provide the maximum protection allowable by law. SLCFPD's obligations to defend and indemnify GPC shall include claims brought by SLCFPD's employees, agents, and subcontractors. SLCFPD shall be solely responsible for the use of the Equipment and for alleged failure of the Equipment to adequately warn persons or the public, and SLCFPD shall defend, indemnify and hold harmless GPC, from any third party claims alleging that the Equipment's failure to warn any person or the public, or has caused or contributed to any damage, injury, or death of any person or property. SLCFPD acknowledges and understands GPC does not monitor power availability at the License Area, and SLCFPD assumes all risk that power for its community notification siren may fail for extended periods. For clarity, failure of the siren to operate or operate properly because of a lack of power, for any and all reasons except the gross negligence of GPC, shall be the sole responsibility of SLCFPD.

- 2. The scope of the indemnity intended by the Parties to this Agreement shall include any claims for personal injury or death, as well as for destruction of real or personal property, caused, in any way, by the operations and activities of SLCFPD in or around the License Area or the use of its Equipment. SLCFPD agrees to hold GPC and its officers, employees, agents and vendors harmless from any such claims, including reimbursement of attorney fees or costs associated with said claims.
- 3. SLCFPD agrees that GPC is not the employer of any of their employees, or any of the persons using or visiting the License Area. SLCFPD is and shall be responsible for the payment and defense of any wage claims, including Worker's Compensation claims and SLCFPD agrees to hold GPC harmless from any such claims or actions.
- 4. SLCFPD agrees that it and any subcontractors or agents it engages are solely and completely responsible for the safety of all work associated with the use of the License Area and the Equipment and SLCFPD shall defend and hold GPC harmless from any claims, fines or actions brought against GPC by any regulatory agency having supervision or authority over it.

III. Insurance Requirements

A. Insurance

- 1. SLCFPD and any subcontractor or agent shall maintain in full and force during the term of this Agreement, at their sole cost and expense with insurance companies having a Best's Insurance Guide Rating of "A-VII" or better (or otherwise satisfactory to GPC) the insurance described below and shall ensure that GPC is named as an "Additional Insured" on all such policies. SLCFPF may self-insure for some or all of this required coverage.
- (a) Commercial general liability insurance, including bodily injury, property damage, independent contractor's liability, contractual, and completed operations coverage, with a combined single limit of \$1,000,000, each occurrence.

- (b) Worker's Compensation insurance with statutory limits with coverage as required under California law.
- (c) Business automobile liability insurance covering owned, non-owned and hired automobile with a combined single limit of, at least \$1,000,000 per accident.
- 2. All insurance policies required herein shall be endorsed to provide that the insurance provided to GPC as an "Additional Insured", under the terms of the insurance policies, is sole primary insurance. All policies shall include a waiver of subrogation and shall name GPC directly.

IV. Payment for License and Termination

- A. SLCFPD agrees to pay GPC Ten Dollars (\$10.00) for this temporary License. Any extension of the term of this Agreement will require further negotiations for the appropriate consideration.
- B. SLCFPD may terminate this Agreement at any time by both 1) giving appropriate written notice to GPC, and 2) removing its Equipment from GPC's parcel and restoring the Licensed Area to its original condition, wear and tear excepted. GPC may terminate this Agreement at any time in its sole discretion by giving sixty (60) days notice to SLCFPD of the termination of this Agreement. After termination, the defense, indemnity and hold harmless agreements contained herein shall remain in full effect.

V. Notices

Any required notices shall be given to the Parties as set forth below. The notices shall be personally delivered, deposited in the U.S. Mail, certified mail or via email. All notices shall be considered delivered when actually received by the Parties.

All previous discussions and agreements, whether oral or written, are hereby superseded and replaced by this Agreement. This Agreement may only be amended in writing signed by the Parties.

VIII. Miscellaneous

Nothing contained in this Agreement shall be construed as constituting a joint venture or partnership between the Parties. Except as expressly provided herein, there are <u>no</u> third party beneficiaries to this Agreement. If any term, provision, covenant, or condition of this Agreement is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remainder of this Agreement shall remain in full force and effect and in no way be affected, impaired, or invalidated.

The Public Entity elects to make this intergovernmental transfer (IGT) to the Department of Health Care Service (DHCS) as a voluntary contribution to the non-federal share (NFS) of Medi-Cal expenditures for purposes of Assembly Bill 1705 (2019) pursuant to Sections 14105.94, 14105.945, 14129, 14129.3, and 14164 of the Welfare and Institutions (W&I) Code. All funds transferred pursuant to this certification qualify for federal financial participation (FFP) pursuant to Section 1903(w) of the Social Security Act and Title 42 of the Code of Federal Regulations, Section 433 Subpart B, and are not derived from impermissible sources such as recycled Medicaid payments, federal money excluded from use as the NFS, impermissible health care-related taxes, or non-bona fide provider-related donations.
- 3. Voluntary contributions attributable to the period of January 1, 2025, through December 31, 2025, will be made via recurring transfers as indicated on the invoices provided to the Public Entity by DHCS. The voluntary contributions made by the Public Entity may also include fee-for-service (FFS) adjustments related to the calendar year (CY) 2023 and managed care (MC) adjustments related to the CY 2024 rating period's NFS reconciliation as described in paragraph seven below. Please note, the total IGT amount at the bottom of this IGT certification will continue to be itemized on your invoice which is sent to you along with this IGT certification form 45-days in advance of the IGT contribution due date. The Public Entity acknowledges that any transfers made pursuant to this certification during this time period are considered an elective IGT made pursuant to W&I Code sections 14105.945 and 14164, to be used by DHCS, subject to paragraph four herein, exclusively as the source for the NFS of ground emergency medical transport public provider supplemental payments in both Medi-Cal FFS payments and the portion of the risk-based capitation rate to Medi-Cal managed care health plans associated with reimbursement made in accordance with Section 14105.945, subdivision (h)(1) (hereafter, the AB 1705 Public Provider Ground Emergency Medical Transportation (PP-GEMT) Program, and DHCS costs associated with administering the PP-GEMT Program.
- 4. DHCS may accept this voluntary contribution to the extent it is able to obtain FFP for the PP-GEMT Program as permitted by federal law. In the event DHCS is unable to obtain FFP for the PP-GEMT Program, or the full payments cannot otherwise be made to and retained by eligible public providers, and, therefore, all

or a portion of the transferred amount cannot be used as the NFS of payments, DHCS will notify the Public Entity via e-mail and return the applicable portion of the unused IGT amount.

- 5. The Public Entity acknowledges that, in accordance with W&I Code section 14105.945, subdivision (h)(2), DHCS shall assess a ten percent (10%) fee on each transfer of public funds to the state to pay for health care coverage and to reimburse DHCS its costs associated with administering the PP-GEMT Program.
- 6. The Public Entity acknowledges that the IGT is to be used by DHCS for the filing of a claim with the federal government for federal funds and understands that any misrepresentation regarding the IGT may violate federal and state law.
- 7. The amount voluntarily transferred to DHCS is based on the estimated Medi-Cal FFS and Medi-Cal MC NFS of ground emergency medical transport payments, as referenced in paragraph three herein. The amounts to be voluntarily transferred to DHCS will be based on an estimate, the Public Entity acknowledges that a reconciliation of the voluntary NFS contributions to the actual NFS expenditures will occur. To the degree necessary to fund the NFS for the PP-GEMT Program, amounts due to or owed by the Public Entity as a result of the reconciliation may be offset against, or added to, future transfers as applicable and as determined by DHCS. DHCS may accept a voluntary contribution to the extent it is able to obtain FFP for PP-GEMT payments as permitted by federal law.
- 8. The Public Entity acknowledges that all records of funds transferred are subject to review and audit upon DHCS' request. The Public Entity will maintain documentation supporting the allowable funding source of the IGTs.
- 9. Upon notice from the federal government of a disallowance or deferral related to this IGT, the Public Entity responsible for this IGT shall be the entity responsible for the federal portion of that expenditure.
