To the Board Members of the South Lake County FPD: November 4, 2019

Dear Sirs,

As the manager of Prather Mountain LLC, one of my duties is to pay the company taxes for our properties located on Siegler Mountain in the Loch Lomond area. These properties consist of a total of <u>ten separate unimproved parcels</u>, all of which are greater than 40 acres. They are zoned as TPZ, and therefore cannot be split into anything less than 40 acres. When I opened the tax bills for these parcels, I was shocked!

According Exhibit A of the recently passed South Lake County Fire Protection District measure L, these parcels are now being taxed at a maximum rate of \$10.00 per unit, with 20 units assigned to each of those parcels for a total of \$200.00 per parcel. Our company tax bill to the district alone is now \$2000.00/year! This is nearly SIX times our last year's tax for the district and we feel it is unjustly high. How did the board decide on how many units were to be assigned to various parcels as defined in Exhibit A of the measure? We know of many owners who live outside the district boundaries that were not made aware of the measure and did not even get to vote on it!

I would like you to explain the reasoning behind the high number of units that are assigned to unimproved parcels, when (1) there is an extremely small chance for the need for an ambulance response to those parcels, (2) most if not all of the parcels within the district are located in the <u>State</u> Responsibility Area for wildfire response, <u>not</u> the <u>Local</u> Responsibility Area, and (3) larger parcels pose no higher risk of a fire start than smaller parcels. In fact, a small parcel with a home on it poses <u>a much higher risk</u> for a fire start than a large parcel that is simply unimproved land!

While it is true that the district would be sending engines and manpower to help fight any fire on those lands, it is also true that the district does not have any fixed winged aircraft, rotary winged aircraft, bulldozers, or organized hand crews to fight fire. Cal Fire would automatically dispatch five type three engines along with those aircraft, dozers, and hand crews to any fire within the district during the peak fire season. It is also a fact that on any large fire, the district engines would most likely be assigned to protect and save structures while Cal Fire would be fighting the wildfire with their vastly superior resources and manpower.

I have no issue with paying the district tax of \$200.00 (\$10/unit for 20 units) for my single parcel with my home on it. I can accept the tax knowing that an engine or ambulance from the district would respond if I needed them. However, I feel that the number of units that has been arbitrarily assigned to *unimproved parcels* for tax purposes is extremely high, unfair, and unjust. For all of the reasons I have stated above, it is my opinion that the units you have assigned to unimproved parcels should be re-evaluated and reduced to no more than five units per parcel, thus lowering the burden of taxes for owners of unimproved parcels.

AN OPEN LETTER TO THE SOUTHLAKE FIRE DISTRICT BOARD

This letter is intended to express my extreme displeasure at the new fee structure imposed by the Southlake Fire District and constitutes my appeal to have the fee structure re-examined to determine a more equitable method of taxing parcels. The following are just a few reasons for this appeal:

- 1. As a non-resident property owner in the Southlake Fire District I was not notified of the 572% fee increase proposed by the ballot measure, nor were any of the other non-resident owners. As non-residents we were denied the opportunity to voice our opposition and ultimately, we were not allowed to vote on this measure which directly impacted us. Why were we not notified in writing of your intentions, and why were we not sent an absentee ballot so our votes could be counted?
- 2. I own a 40 acre piece of ground on Seigler Mountain which has a section line running through it, which makes it constitute 2 parcels. One has approximately 27 acres with a small cabin on it and the other parcel is approximately 13 acres with no improvements. My one piece of property **CANNOT** be split. The County zoning is 40 acre minimum as well as the State TPZ requirements. I have talked to the Assessor's Office and have been assured that even though I have an "imaginary line" running through my land I have only **ONE** piece of property that has two assessed parcels. As such I have to pay the \$200 fee on both assessments, or \$400/year. The adjacent 40 acre parcels that do not have the section line through them pay ½ of that amount. Where is the fairness? Currently, you are charging me a \$200/year fee on a parcel that has an assessed value of \$1,384! I could not even neglect to pay the fee and forfeit the property since it would leave me with only 27 acres in a 40 acre minimum zone!
- 3. The fee structure is basically unfair to the unimproved property owners. You are theoretically charging a lot owner with a \$300,000 house less than the owner of a piece of unimproved property worth only \$1,300. Given equal circumstances who would get priority services, the resident home owner or the non-resident property owner?

4. Last, but certainly not least, as part owner of other family property located on Seigler Mountain, we are being assessed an additional \$200/parcel for each of these 6 parcels also. This property has been in our family for many generations and we have always prided ourselves with keeping it well maintained and fire safe. We maintain a program of winter burning as well as removing dead or dying trees to keep the forest healthy. During the Valley Fire we were able to keep our mountain and much of the surrounding community safe because our property was well maintained. We spend thousands of dollars each year on our burning/cutting program to try to keep our forest fire-safe. Will Southlake Fire District spend any of the funds that we will have to divert from protecting our forest to help us with our winter burning program?

Our family started the first volunteer fire department at Loch Lomond. We subsequently DONATED the property for the current fire house there. My father sawed and donated much of the lumber used to construct the new fire house and our family helped build it. We even DONATED the first fire truck for the fire house! We understand the importance of fire protection. We do not understand the need for **SO MUCH MONEY!!!** Under the current fee structure the Prather family members alone will be paying over \$5,000 per year!!!

People are always telling us how fortunate they are to live in the Loch Lomond area and enjoy their view of the beautiful and scenic forest of Seigler Mountain. However, I fear that we will not be able to afford to save our forest for future generations. It is just too expensive to keep property that is not producing any income. We may have to find some developer with enough money to rezone the property and subdivide it for housing.

We hope you will reconsider your method of calculating these fees and come up with a more equitable way to assess the unimproved parcels in the district.

Re: Salary Comparison from Fire Apparatus Engineer/Paramedic to Fire Captain Paramedic Classifications

RECOMMENDATION

The following recommendation is based on cost effectiveness for the Fire District. Through attrition we recommend that 2 Fire Apparatus Engineer/Paramedics be converted into Fire Captain/Paramedic positions. Through attrition this could be achieved, historically speaking with attrition rate, within 18 months.

EXECUTIVE SUMMARY

The intent of providing this information is so the BOD can analyze the fiscal impact the District has had with recruitment and retention of Fire Apparatus Engineer/Paramedics. The District like all Fire Departments has been challenged with retention for years. From 2012-2016 there was a total of 23 people hired in that time frame with a total of 7 people saying longer than 2 years. Of these positions 15 accepted Permanent positions thus creating the future vacancy. This was a total retention rate of 48%. From the timeframe of January of 2018 through September of 2019 out of 17 people we retained 8 in the Paramedic classifications. The 9 we lost were due to 3 promotions to Fire Captain, 2 accepting jobs with outside agencies, 1 accepting a permanent classification, 1 hardship transfer, 1 medical retirement and 1 resigning prior to appointment. This was a retention rate of 47%. These retention numbers have caused financially impacts due to the District funding the individual going through the academy, along with backfilling their position while they are in the academy with Overtime. Occasionally some of the individuals hired have left prior to starting their assignment or have left within the first 12 months of accepting the assignment to South Lake County Fire.

BACKGROUND

The South Lake County Fire Protection District has approved through the contract for the following classifications. 1 Fire Captain, 1 Fire Captain/Paramedic, 1 Fire Apparatus Engineer, 6 Fire Apparatus Engineer/Paramedics, 2 Firefighter II/Paramedics, 1 Limited Term Fire Apparatus Engineer/Paramedic, and 1 Limited Term Firefighter II/Paramedic. These 11 positions provide 24/7 coverage between 2 staffed stations in the District. Station 62 and Station 63 have year-round staffing. It is extremely common to run 9 out of 11 of these positions, dropping down to 6 out of 11 at times depending on people leaving for various reasons.

ANALYSIS

This section would analyze the situation or issue from the current perspective and may include some or all the following items:

Environmental Impacts – None

<u>Fiscal Impacts</u> – The District should see an initial \$45-\$50,000 savings per year, per position. The District should see a \$30 - \$37,000 savings per year, per position in the years after established. The two positions would double these numbers.

Bottom Step

Comparison between the classifications of Fire Apparatus Engineer (Paramedic) and Fire Captain (Paramedic). The numbers we ran were for both Bottom Step FAE/P and FC/P as of July 1st 2020.

Hiring a FC/P would not require sending them through a Fire Fighter Academy or Company Officer Academy. The reason behind this would be due to the fact of our hiring practices. To qualify as a FC/P you must have completed FFA, COA and JAC training. However, hiring an FAE/P would require both academies along with coverage behind them while they are attending. Here is the comparison of additional funding for this variable.

The salary and EDWC for a FAE/P to attend the academies for a total of 14 weeks (3.5 months) would cost \$23,376.50 for the attendee. The OT required to cover behind him would be an additional \$29,393.28. The average travel expense for each 14 weeks would be an additional \$4,000.00. This would be a total of \$56,769.78.

There is additional JAC courses that every FAE/P is required to take in their three-year Apprentice Program. The number of courses equals an additional 24 days of training which will require the FAE/P to attend. Thus, creating 24 days of OT behind the FAE/P. The cost for the employee to attend the formalized training would be \$13,858.32. The cost to cover behind the employee would be \$16,796.16. This would be an additional \$30,654.48.

We ran an overall average of 50 days of OT per classification behind vacancies and other staffing challenges. The difference between 50 days of OT between a FC/P and FAE/P would be an additional \$2,856.00.

To conclude there would be a Field Training Officer time for accreditation. Each employee would have to go through approximately 4 weeks of FTO time based on past practices of our call volume and wait time from our LEMSA.

Here is the comparison of additional funding for this variable.

The OT required to cover behind him would be an additional \$37,144.80. The average travel expense for each 14 weeks would be an additional \$4,000.00. This would be a total of \$70,046.40.

The cost for the employee to attend the formalized training would be \$16,515.20. The cost to cover behind the employee would be \$21,225.60. This would be an additional \$37,740.80.

We ran an overall average of 50 days of OT per classification behind vacancies and other staffing challenges. The difference between 50 days of OT between a FC/P and FAE/P would be an additional \$4,944.00.

To conclude, there would be a Field Training Officer time for accreditation. Each employee would have to go through approximately 4 weeks of FTO time based on past practices of our call volume and wait time from our LEMSA.

C1.4. Chief's Report

Battalion Chief Wink:

- Introduced office technician Jennifer Zientek. She grew up in Santa Rosa and has lived in Lake County for 15 years, graduated Sacramento State in 2013 with a Bachelor of Arts in Organizational Communications. Prior to coming to employment here, she worked for Tri-Counties Bank in Middletown part time for almost two years.
- Reports: It will be busy next couple of months with training, low angle rope rescue training, swift water training, snowcat training, fire control 3 class with live fire training, and exterior demo fire extinguishing training.
- The group is finalizing their consultant candidate. Being discussed is benefits to present adjustment for Board approval. One member from our team and their team interviewed 6 candidates.
- After repurposing generators to Cobb Lions and other to school,
- One generator went to Cobb and other to school. With trailer donated by staff member, the generator was made portable. Staff did all construction with cost in neighborhood of \$1,500. It operates using propane to support others in the district with 22 kilowatts.
- He talked to Association President Fenk about recruits. It's a hard balance with 3 or 4 seats available to us in the academy and most eligible for employment with Cal Fire. It is good and bad but helps with community. They get on with good training, with 50% ending up in career. Director Garcia agreed there are positives and negative is people come motivated, looking towards career. As a fire chief he'd advocate to others to do exactly as they are doing now, do job, do training and gain as much experience. The benefit is you get highly motivated people and that's important. He understands the problem and it goes with the territory. Some suggestions being made he's not are allowed.
- School started fire science ROP program. This came last minute, and we are happy to help.
- Unusual opportunity came up for the Loch Lomond station where 3-days labor is being donated. It's in need of attention to get mold removed, leaky roof repaired, and asbestos floor tiles removed. Some material purchased locally and rest he couldn't get purchased from Home Depot. Director Martinelli offered to forward this to the Loch Lomond Property Owners Association for possible donations.
- During the public safety power shut off (PSPS), the overall impact to the district was minimal. We learned we needed to mitigate a few things and purchased for each station old school telephones that plug directly into the wall and wireless antennas for stand-alone computers to access hot spots available in the ambulances.

C1.5. Financial Report

Gloria reports:

- Two calls were received regarding property tax assessments, one from commercial property owner and second from Tax Collector Office, who've received a number of calls that they've referred here.
- GEMT for fiscal year ending 2019 will be due November 30th and is looking into Assembly Bill 1705, which appears to be Inter Government Transfer for public agencies.

 Progress continues with WinCAMS. Budget summary provided is in old format in order to provide Board a synopsis of where district finance stands, which is budget is on target for first quarter without Cal Fire's 1st quarter invoice that is normally not received until December.

Directors Garcia and Bostock have no activity to report.

Director Comisky commented that although many locations and systems were impacted with 3 days without power, it will have caused significant fire without the PSPS. He notes an appliance to go on meters without wires and by 2020 PSPS season may be available for people to purchase and receives 40 amps of power.

Director Martinelli reports the friend she mentioned at last meeting who received notice from Cal Fire about trees needing to be taken down. The person contacted PG&E. No progress has been made yet but there's a phone number to call. Cobb Area Council received \$200,000 grant to plan for economic development.

Director Hoberg reports he'll be out of town due to work commitment during next meeting and asked Director Garcia preside.

D1. Consideration for proposed additions / changes to Memorandum of Understanding By and Between South Lake County Fire Protection District and South Lake County Volunteer Firefighters Association Inc. for Paid-Call (PCF) Personnel. Placed on the agenda by Association President Todd Fenk.

Association President Fenk asked Board to make consideration and segway from earlier enhancement to interfacility transport (IFT) program and focus on emergency medical service (EMS) side which are a large portion of district calls. Firefighter/EMT Kimberly Miinch will head the program and shared what it will mean to community and PCF program. EMS specialist / IFT specialist can do community programs, looks to look into general idea "stop the bleed" program, help schools with disasters and hands only CPR. PCFs are not excluded; this spot for EMT is for those not interested in firefighter program. IFT program had hiccups and IFT specialists were not able to go on calls but have helped with dinner and Association matters, fires wanting Red Cross instead of taking firefighters off engines to assist with rehab and evacuations with hospital. She feels good mix for a group who much rather be on ambulance than on fire. Clearlake abandon IFTs because it's not enough money, Lakeport is doing a little, Kelseyville doing what they can, and IFT specialist Leuzinger who works at the hospital has seen some patients wait hours. Currently we have 4 EMTs that are PCFs, who have time to run calls but just not the 12 hour shift, do a lot and make a difference in the shorter times

No financial impact, a pay structure already exists. There's no need for new gear. This may lend itself to getting more PCFs on the EMT side. Position duty statements to follow.

After some discussion about the job descriptions that are still in development stages and will be brought to the next Board meeting for consideration, **GARCIA/BOSTOCK MOTION** to approve additions to MOU as presented. AYES: Comisky, Martinelli, Bostock, Garcia, Hoberg. NOES: None. **MOTION CARRIED**.
